(Hereinafter “Client”) and Community Care Services, Inc. (hereinafter “Consultant”) for specialized consulting services. The Consultant agrees to provide educational consultation services in the form of information, technical assistance and guidance. This can include sharing of information, seeking out appropriate resources, attendance at school conferences, TEAM meetings and mediations.

The Client understands that appropriate releases for the exchange of information must be signed. This release will provide needed documentation to the Consultant and will permit the Consultant to attend scheduled meetings.

Community Care Services, Inc. and its staff will not initiate hearings with the Bureau of Special Education Appeals, nor give legal opinions or representation. The Consultant will assist and prepare the Client for any action or steps that the Client wishes to conduct, including any meeting or hearing process.

The Client understands and agrees to pay \$65.00 per hour for these educational consultation services. The Client will be billed monthly. A retainer of \$650.00 (checks made payable to Community Care Services, Inc.) must be received before services can begin and must be replenished with funds up to the \$650.00 level when the remaining account balance reaches \$130.00 before additional work can continue. The Educational Consultation Services’ program manager will resolve any disagreement with regard to services or invoices.
